Chennai, Jan 13:

State Minister for Forests, Dindigul C Seenivasan, visited Arignar Anna Zoological Park on Thursday and reviewed the progress of work being carried out in the wake of Cyclone Vardah's destructive trail.

He discussed the preparedness of the officials for re-opening the zoo at the earliest.

Vardah caused extensive damage to trees and utilities all over Chennai. Tiruvallur and Kanchipuram districts also saw its devastating effects on trees and amenities in Arignar Anna Zoological Park, Vandalur, and Guindy Children's Park.

While Guindy Children's Park has been re-opened for visitors after restoration, officials are on their toes to re-open Vandalur zoo, as well, at the earliest.

'Efforts are being made to re-

store the zoo to normalcy and ensure the safety of animals and the visiting public. Rebuilding of animal enclosures and repair of visitor amenities are being carried out on a war-footing. The remaining work will be completed as soon as possible,' said a zoo official.

The officials of the fire and rescue services department visited the zoo on 6 and 7 January. The district fire officer has opined that there are chances of fire inside the zoo due to the presence of these materials and so the zoo could be opened to the public only after removing these materials.

'Considering the safety of animals in the zoo and the visiting public, the zoo could not be opened before Pongal holidays,' he said.

Guindy Children's Park was re-opened on 30 December, as also Vedanthangal bird sanctuary.
